These requirements demand a capacity to manage one's own psychic processes whilst attending to the psychic processes of patients with a wide range of complex difficulties. We therefore have a safeguarding responsibility for anyone undertaking the training (as well as their patients) who has a mental health history that could be put at risk by the demands of the course.
